# TERMS AND CONDITIONS

## ELIGIBILITY

I understand to qualify the refrigerator must be a NEW energy star\* for the sole purpose of being my primary refrigerator installed in my kitchen. Second refrigerators or mini refrigerators do not qualify.

I understand I am not eligible if I participated in the refrigerator replacement program after July 1, 2018.

I understand to be eligible I must already be enrolled in the low income program before the purchase date of my energy star refrigerator.

I understand that a rebate will not be paid if I am not enrolled in the low income.

Rebates are on a first come first serve basis, the program will end when all approved funding has been spent.

I will provide, if requested, a Colton Electric Utility representative reasonable access to my residence to verify the installation.



## APPLICATION

Copies of proof of purchase showing products were paid in full and any additional supporting documentation must be sent to Colton Electric Utility postmarked no later than four months unless approved by administrator from when the unit was purchased.

I am responsible for filling out the application completely, truthfully and accurately.

I understand that Colton Electric Utility is not responsible for items lost or destroyed in the mail/transit.

## TIME SCHEDULE

Please give The City of Colton Electric Utilities Department adequate time to review and approve your application. The approval process may take up to three weeks.

## PAYMENT

**The rebate is not to exceed 1 refrigerator per house every ten years.**

Payment of the rebate is conditional that all correct supporting documentation be submitted with application. Colton Electric Utility will mail rebate checks for qualifying items within six weeks of receiving a completed application. Rebates will not exceed the cost of the purchased item.
